## One President's Holiday Message

It's the holiday season. The aroma of cookies baking, Christmas carols being sung, and the smell of fresh pine needles always gets to me. It heightens my Christmas spirit. It pulls me into the past as well as the present. I remember family and friends no longer here and joyfully spend time with those that are.

This holiday season, Kathy and I spent some time watching holiday romantic comedies. Yes, we freely admit to becoming Hallmark Channel junkies. Our holiday schedule normally leaves little time for this type of activity. There is so much to do during the days leading up to Christmas. But, lately, we find that slowing down our daily schedule is helpful as it reduces the stress of the season. The decorating, gift buying, cookie baking, and Christmas card addressing still got done, but we limited both the volume and complexity of each task. We find that reducing our expectations, and with that our stress, helps us both to better navigate through the time leading up to Christmas.

## Zion Council Reorganizes for 2023

Following Zion's congregational meeting on November 20, 2022, Zion council, at it's December meeting reorganized for 2023. The council welcomed new member Dory Campbell who will be serving a full three year term. Several committee assignments were finalized with Becky Slade joining to the Property committee and Dory Campbell joining the Evangelism committee.

The council then elected officers for 2023. The officers elected are:

Council also decided to set the date for a congregational meeting to follow up on final consideration of the proposed amendments, by-law changes and continuing resolutions that were discussed at the November meeting. The date for the congregational meeting will be **Sunday**, **March 26, 2023,** following the 9:30 AM service. As per the constitution, letters will be sent to all members of the congregation announcing the meeting date and time in January to fulfill the 60 day notice requirement.

Council also agreed to re-open consideration on the Nave roof replacement project at that same congregational meeting. Repair and sealing of the current roof was completed in November, giving the roof an additional five years of life. Council feels that the money currently earmarked for the roof replacement could be redirected to support other more critical needs within the congregation and will entertain discussion to this end.

The Stewardship committee also announced that letters will be sent in early January to those who made pledges to the 2022 current and benevolence budget, updating those who pledged on their final giving amounts. Please note that this letter is **NOT** the official contribution amounts needed for taxes. Those will be sent under a separate mailing and will include **ALL** of the contributions made to C&B and other Zion initiatives. Letters confirming pledges made by members for the 2023 current and benevolence budget campaign will also be mailed in early January.

#### Administration and Finance - Kevin Huston

2023 Budget – The proposed budget was discussed. The income line for loose offering, Christmas and Easter offering was determined by estimates from previous years. Sue had asked how those amounts were determined.

There was a discussion on the listed salary for Director of Music. There was an increase listed, and it was stated that the pay was going to change to salary instead of being paid per Sunday. After some discussion on the amount, a motion was made by Dave, and second by Becky, that the salary be budgeted for \$13,564 for one year allowing 4 vacation days. Motion passed with 7 yeah, 2 no, 1 abstain.

Annual Reports – Kevin presented a council annual report to be included with the other annual reports. Please look this over.

Annual Meeting (Nov. 20, 2022) - A Copy of the agenda was presented for review.

Constitution Amendments and bylaws- We were given lists showing the suggested changes to the Constitution and Bylaws that council worked on in the spring. These amendments will be presented at the annual meeting. But they will have to be voted on at a special meeting to be called in January 2023.

#### Social Ministry - Sue Dickson

Food Pantry Closure – With the Food Pantry closing, the Social Ministry sent a request to council for distribution of the remaining funds. There is a balance of \$16,308.18.

\$1,000 used to purchase grocery store gift cards for the Pastor's Discretionary Fund. \$1000 to be donated to Chevy Chase Community Food Bank

\$14,308.18 remaining balance to be deposited in Zion's Endowment fund.

Discussion followed on what to do with the 14k remaining balance. If the amount is put into the Endowment fund the uses will be very limited. The money was donated to be used for the food pantry so the feeling among the council was that it should be donated for those same uses. This will be presented to the congregation at the annual meeting, along with some ideas for local food pantries.

## ADMINISTRATION AND FINANCE COMMITTEE MINUTES

## <u>December 7, 2022</u>

#### I. Call to Order - 6:02 pm

Present: Kevin Huston, Sue Dickson, Pernell Bowersox, Kim Balcerak, Rik Wissinger, Gail Sechrist, Pastor Tedd Cogar.

November Minutes- reviewed, motion to approve by Rik, second by Kim.

#### II. Financial Report

- a. November Financials November income was slightly less than budget. Expenses for the month showed property expense and office equipment running high. This year is still on track to have a surplus.
- b. There is a CD coming due in May at 2.42%. Early 2023 discuss where to reinvest.
- c. Money in our S&T savings account that is not designated for anything totals about 74K. Should we put that into something that could give more interest than in S&T savings?
- d. Memorial fund money- \$19,600 (Bequests Undesignated, and Undesignated Memorials line item). These have sat in the accounts. Are there uses for these? Motion to move the reports to audit made by Rik, second by Kim.

#### III. Old Business

- a. 2023 Budget The income line has been updated due to some late pledges.
- b. Fish Estate John Barbor called. The State Attorney General has approved the estate paperwork. Distribution expected in January. The estimated gift amount is just over \$500,000. Per our constitution 10% of the gift must go into the Endowment Fund.
  c.On Line Project no update

#### IV. New Business

A. Congregational Meeting to Approve Constitution Amendments- a 60 day notice is required. March 26. Notices will be sent to the congregation by mid-January.

B. Pantry Money Distribution –

Sue presented a list of area Food Pantries that we could donate the food pantry funds to. \$1,000 will be used for food gift cards for Pastors discretionary fund. Will be distributed to those in need that call the church. Present list to council.

#### C. 02 Account Review and reorganization - a 2023 project

A review of the o2 accounts should be planned for first of the year. Kevin noticed some that look like duplicates or no longer being used.

D. Capital Improvement Project status -

With recent repairs to the slate roof should we reevaluate continuing with replacement? The repairs supposedly added about 5 years of life to the roof. If delayed what should be done with that portion of the gift? This information to be discussed with congregation.

E. Pastor presented information about a student looking to do a type of externship at Zion. He is a Masters of Divinity student through Liberty University. He wants to work with Zion as part of his class (Jan to May), about 10 hrs a week. The Bishop has said that there is nothing preventing us from having an extern from a *non ELCA seminary*. He would be working under Pastors guidance. As for finances there is no salary. This needs to be brought up to council. Motion by Pernell, second Kim to follow Tedd's recommendation to look into this.


