Traditional Sunday Worship Service to Resume on June 6th

The Worship and Music committee is pleased to announce the resumption of our traditional Sunday worship service on Sunday June 6. The basis for this change was provided by the CDC's decision to modify their guidelines concerning mask wearing and gatherings for fully vaccinated people. Those guidelines have approved the congregating of vaccinated people without masks and allow for "choral singing" indoors by the fully vaccinated. The committee discussed these new guidelines and decided that this allowed us to return to our "traditional" worship format. We recognize that some may still be hesitant to return to in person worship and we will continue to offer our on-line worship format for those who wish to continue worshiping from home. We also recognize that this change in policy may cause concern for those who are still unable to be fully vaccinated. We hope that those individuals who fall into that group will make the best informed choice for themselves and their loved ones. The Worship and Music committee's mandate is to provide meaningful worship opportunities for the congregation and we have struggled to fulfill this mandate during the past fourteen months. We hope that the congregation will understand that we continue to do our best to fulfill our obligations to you by providing meaningful worship opportunities in an environment that is welcoming and as safe as possible. We will ask that ALL congregation members entering or leaving the Nave and walking up to receive communion continue to wear their masks out of respect for those in attendance who may not yet be fully vaccinated. The Worship and Music committee wishes to express its heartfelt thanks to the congregation for your patience and understanding during these past months.

Beginning with our Sunday service on July 4, and continuing through the end of August, the committee is asking that the congregation select our communion hymns. A hymn request form is located below. Please use this to send in your favorite hymn. Every opportunity will be made to schedule all hymn requests in the coming months.

The lone exception will be Sunday July 25. Sunday July 25 in the half year anniversary of Christmas and the committee thought it would be a great opportunity for us to celebrate Christmas on that Sunday. We are planning a traditional Christmas service for July 25th. The church will be decorated for Christmas and we will be singing our traditional Christmas hymns. Pastor Cogar will be preparing us for this service by providing Advent liturgies on the four Wednesdays prior to July 25. (June 30, July 7, July 14, July 21). These liturgies will begin at 7:00 PM

WINDOWS, WINDOWS, WINDOWS.....

Did you know how many windows make up Zion's Nave and auxiliary building space?

And the answer is 118.

Zion has all kinds of windows. Small ones, large ones, plain glass, and stained glass make up the menagerie of windows that both beautify and protect our ninety-seven year old worship and meeting space. The property committee has been discussing the condition of our windows and has earmarked them as our next big agenda item, following completion of the ZARP projects. We have had preliminary talks with painters and have discovered during those discussions that simply painting the window trim will not be the best solution. The church's windows have not been worked on since the 1970's. While we have enjoyed fifty years of expense free coexistence with our marvelous stained glass windows, time has finally caught up to us.

We have now turned to a source who does church restoration. After meeting with this group we are convinced that the windows need restoration as well as painting. Our stained glass windows are in especially poor condition. They are pulling away from their metal supports and the channel lead is now brittle and in some cases flaking off. All of this is repairable of course, but the cost will be a major obstacle and it will take time to adequately address all of the repairs.

We have detailed the projected project costs below. Failing to address this is not an option. What we must do is find a way to get the project completed so that our building can be restored to its intended beauty.

Total Project Cost	\$224,700.00
Cost to replace all exterior protective window coverings	\$ 82,300.00
Cost to prepare and paint all 118 exterior window surfaces	\$ 26,000.00
Cost to repair ALL stained glass windows	\$116,400.00

The average cost per window - \$1,904.00

In addition, during our building inspection with the restoration company, we identified three additional areas of concern that should be addressed.

Cost to prepare and paint the bell tower louvers	\$ 16,000.00
Cost to prepare and paint the fascia, siding and soffit	\$ 13,920.00
Cost to prepare and paint the three main entry doors	\$ 5,280.00

In addition to the cost, the project will take time. It is expected that the work will consume much of 2021, 2022 and 2023. So if we decide to pursue this project, we will need to contribute generously and be patient as the work progresses.

Our current Capital improvement budget balance is 59,366.91. We have committed \$ 6,933.00 for renovations to the third floor Sunday school area, which will be completed in time for fall classes to begin. This leaves us with a total of \$52,433.91 for the window project. Our needed funds for addressing the window project is \$ 172,267.00. Adding in the three other areas of concern would increase our needed funds to \$207,467.00.

Over the coming months the property committee, administration and finance and your church council will be debating how best to approach the project. We ask that you give thoughtful consideration to helping us to find a way to save our magnificent church building.

April 12, 2021

- **iii- Approval of March minutes-** A motion was made to clean up the wording of the March Minutes: Correct it to say Gary Ellenberger has volunteered to host a workshop.

Review of Gift Policy- Some minor revisions were suggested to clean up the wording of the gift policy, and a discussion ensued. M/ B. Slade, 2nd K. Balcerak- motion carries with minor corrections as noted during discussion. K. Huston asked the council if Ryan Ebner should be asked to attend the May Council meeting, or to have The Administration and Finance Committee meet again with Ryan. It was decided that the AdFin committee can meet again with him.

Pastor's Report- Pr. Tedd- Will find the best way for virtual services in conjunction w/ live services, he will explore other options to increase the quality of the Audio.

v- Review of Financial Report (March 2021). \$3500 exceeded expectations for March. Money set from budget challenge \$5220 aside in O2 account Motion to send for audit. There was an expense for organ repair and maintenance; an organ repairman happened to be in town; the harpsicord repair was more in depth than anticipated.

vi- Committee Reports

Standing committees

- **Administration and Finance** K. Huston Budget Challenge to congregation follow up- \$17013 has been committed as of tonight from the congregation. Thursday, April 15th is the deadline. To date there have been 51 numbered envelopes who have contributed.
- **-Shaffer Gift** Ross Shaffer left \$10,000 to Zion, and requested it be used to reclaim property from parsonage demolition- It will be set aside in ZARP account for that purpose. Demolition is expected to begin this week or next week beginning with the chimney.

Staff Support- R. Wissinger- no report (absent)

Constitution Compliance- B. Slade audit workshop- Gary Ellenberger is available June 19th beginning10am. The audit workshop will give 9 people an overview of how to conduct and audit she will include herself, plus 8 others. The larger group will break up into smaller groups, and Gary will bounce around and check in. The group will break for lunch, then complete the workshop. There will be 9 people trained for Audit. Zion needs to dispose of records, they only need to be kept for 7 years. We will look into renting a shredder, or possibly burn them. A note will be put in the newsletter to look to volunteers for the workshop.

Evangelism/ Stewardship- Sent out questionnaire for congregation, to have contact information updated. So far, there have been 72 Replies. At the end of the month, a second letter will be mailed to non-responders. Give people an option to become associate members if they wish to no longer be active members.

April 12, 2021

Parish Education- G. Sechrist- VBS will be held on Saturday Aug. 28th at Blue Spruce Park, and will be a 1 day event.

Property- D. Keith- On, Wednesday, a company which specializes in painting and refurbishing church windows inside and out will visit the church for an estimate. There are 140 + windows. Get started on it. Two bids were received to paint the Sunday school area. A bid from Western PA Service \$6900.33 was the low bid. Money will come from the capital improvement fund. K. Huston, made a motion to accept the low bid. Everyone present voted yes.

Rec & Fellowship- K. Gaylor. As soon as its safe, Rec & Fellowship will host a potluck dinner in the social hall. There has been interest in re-starting the food pantry there are multiple people interested helping. The proposal is to have it 1 time per month as a drive thru. May 15th was proposed as a start date, and have it the 3rd Saturday of each month. K. Huston suggested submitting information in the newsletter, K. Gaylor will write something up. Pr. Tedd suggested we make Indiana borough police aware for traffic control. There will be some kitchen repairs made in the next week or two. The fire alarm pull station will be lowered to make it more accessible and there is an unnecessary fire suppressant line above the stove that will be deleted.

Social Ministry- No report

Trinity 3-2-1- There have been requests to negotiate a different time schedule for service. Luther chapel would have to move to an earlier time and would need to be consulted with. Their next meeting is May 18.

Worship and Music- Pr. Tedd asked if there were any concerns with how Communion is offered. Right now, he's pre-filling plastic cups, and setting a wafer on top, and setting them on a tray and allowing members to commune themselves. A suggestion was made to make an announcement where the trays for used cups are placed, so the plastic cups can be disposed of. It was suggested that Saturday evening services resume in May. May 1st was suggested. An announcement will be put in the next newsletter. A suggestion was made to sing a hymn at end of service as people stand at their pew. A lengthy discussion ensued, and it was decided that we stay as we are until May 31, then reevaluate at that point.

ADMINISTRATION AND FINANCE COMMITTEE MINUTES May 5, 2021

Present: K. Huston, Pr. Tedd, Dawn Seagren, S. Dickson, G. Sechrist, Rik Wissinger, B. Swatsworth met w/ Kevin earlier in the day.

I-Financial Report- The income for the month was higher than expected, the expenses were slightly lower. Even without including the \$18,000 Budget Challenge money from the generous donor, the budget is looking better. There may be no deficit. We may want to put an announcement in the newsletter for members to designate budget challenge donations from their regular offering. Motion to send financials to audit- Sue Dickson, 2nd by Don Seagren; motion passes.

II- ELCA Foundation- Ryan Ebner was present to answer questions and to speak to the Committee. To move forward, he needs a version that's adopted by the congregation. We are able to remove watermark to remove "draft" add tax ID #, there are some minor revisions that need to be done. There was a lengthy discussion and presentation. Our current investments are not generating much of a return. Since its inception in 1991, there has been a 5% rate of return. Over the last 5 years, the rate of return was 8%. Over the last year, the rate of return was 12%. All management fees were taken out before calculating the rates of returns. Once an entity makes an initial investment (\$25,000 minimum) they receive a certain number of shares. Once per quarter, there is a distribution of a return on the investment which can be reinvested with the foundation. It can also be withdrawn and used however the church would want. The goal is to help congregations have stable distribution to utilize for ministries. There is a governance of administration which utilizes managers, there is also a consulting firm that ensures investors are doing what they should be doing. Oversight is done by a of board of trustees. Ryan would be the point of contact as the regional gift planner. The foundation works with Portico https:// porticobenefits.org/; they handle retirement funds, benefits. They have 80 billion in assets. All members of the foundation receive the same rate of return. We wouldn't have to choose how the money is invested. The foundation keeps 4% in cash liquidity to honor distributions, or if someone needs to withdraw. Some examples of investments the foundation makes are in equities, bonds, global real estate. Power generation, windmills, natural gas- alternative investments, all good for the environment. The investments do not compromise our faith for the sake of a profit. They try to find things that are beneficial. Like any investment, there is risk involved. Not all years are great. This would be a long-term investment. The distribution of return could be used for building repairs, we are looking for long term stability. Can dictate what return goes to, Ryan stated that a church in Uniontown designates their return towards building maintenance, outreach/ ministry, to pay for office manager and a music endowment K. Huston- yea or nay? Yes, move forward.

ADMINISTRATION AND FINANCE COMMITTEE MINUTES—cont May 5, 2021

III- On Going Congregational Issues-

- a. Constitution- Still in limbo. Not approved yet.
- **b.** Property projects- **i**-Sunday school painting, starts as soon as the kids are moved out of the area, we will get an estimate for pricing on flooring from Affordable Interiors.
- **ii-** Window painting bids- At first, the thinking was that the windows were going to need a simple painting job; they were last painted in 1970's. Elias painting in Johnstown specializes in church painting; the project is more in depth than they thought, but they have a guy who does this kind of window work. There are 118 windows, and the project is going to be very expensive. \$100,000 may be in the ballpark. The front vestibule is leaking, could be a masonry problem. Brian Mehus will have a mason he knows contact Kevin Huston to make a determination.
- **c.** Expanded worship opportunities (Saturday evening)- Thirteen people attended a spoken worship service. It didn't appear to subtract from Sunday attendance.
- **d.** Budget challenge- Total pledge amount from congregation was \$18,013. Zion recently received check from the donor for \$18,000. A suggestion was made to hold it in its current location as a budget surplus in case there are a rise in expenses, or a downturn in offering.
- **e.** Congregation contact information- 90 responses were received back from the congregation. A letter will be mailed out to non-responders next week. A suggestion was made to create a spreadsheet, maybe have a church directory. Jen Rising volunteered to handle readers.

Completed Projects

- 1. April 28, 2021 Boiler Inspector did not approve boiler repair. Metal pipes are required.
- 2. April 29, 2021 Eastern Elevator performed their quarterly maintenance.
- 3.May 10, 2021 Eastern Elevator and Inspector performed an every three year elevator test/inspection
- 4.May 10, 2021 Received bid from Elias Church Restoration for Window project \$ 224,700.00
- 5.May 10, 2021 Received bid from Elias Church Restoration for Bell Tower \$ 16,000.00
- 6.May 10, 2021 Received bid from Elias Church Restoration for doors \$ 5,280.00
- 7.May 10, 2021 Received bid from Elias Church Restoration for soffits \$ 13,920.00

- 1. With the demolition of the Parish House, the committee approved having electricity installed to the garage. This will be done by Pardee at a cost of \$700.00 **Completion Date July 2021**
- 2.March 19, 2021 Heavy rain exposed a continuing leak problem at the sixth street entrance to the church. Several contractors have addressed this in the past but no permanent solution has been obtained. This continues to be an ongoing issue. The committee is looking for solutions through Masons and roofing contractors
- 3.April 12, 2021 Council approved a bid from Western PA Service Company for \$6,933.00 to repair, prep and paint the third floor Sunday School rooms. **Completion date July 2021**
- 4. Three outlets in third floor Sunday school area need to be updated. Completion date July 2021
- 5.Bathroom faucet on third floor needs to be repaired. Completion date July 2021
- 6.Replacing the flooring in third floor Sunday school area needs to be addressed. **Bids are being secured.**
- 7. Fire box in pre-school is positioned at a height that would allow children to engage it. Jerry is calling the Indiana Fire Department to see if we can either move or cover it
- 8.Pastor Tedd has asked for a screen door on the Pastor's outside office door to be installed. The committee has taken this under consideration

- 1. The committee discussed the altar flowers. It was decided that we would continue to use the silk flower arrangements through the summer months. Beginning with Sundays in September, we ask that the congregation return to our former altar flower program. Please use the calendar on the bulletin board outside the nave to sign up for weekly flowers or call the church office to reserve your week.
- 2.The committee discussed continuing to post the Sunday services to Facebook and the web site. Update Sunday school classrooms
