

The Worship and Music Committee has been closely monitoring the viewing reports for our live streamed Sunday worship services. We continue to see our view numbers exceeding 100 each week. # May 10, 2021

#### i-Call to order

#### iv- Communications-

Pastor's Report- Pr. Tedd- Utilizing a laptop computer to broadcast worship services is working better than using a phone. VBS moving along with planning. A one day VBS at Blue Spruce Park is planned on 8/28/21. He is working on getting someone from the campus center for music that day. Pr. Tedd is going to be away the weekend of May 28,29 and 30. There will be enough consecrated elements for a service. Pr. Tedd is going home the1<sup>st</sup> weekend in July for a family reunion. We will reach out to synod for assistance for that weekend.

#### Discussion on future of ministry at Zion-

**Followup on meeting with Pastor-** Pr. Tedd asked if there are more things that he can be involved with. R. Wissinger will bring it up at Trinity 321. This Saturday- food pantry distribution, Pr. Tedd will be there.

**V. Review of Financial Report-** Things are looking good. There is a savings of contributions to Trinity 321 due to Pastor Sarah departing. Things are tracking towards a neutral budget. New website- zionindianapa.org. There should be an announcement in the newsletter. Online giving is up and running. Special Focus Envelope- \$18,000 from anonymous donor, keep it in reserve. There should be a notice in newsletter for congregation members to separate the budget challenge money from their regular donations. Ad fin motioned to send financial report in for Audit.

#### vi- Committee Reports

#### Standing committees

#### Administration and Finance- K. Huston

- Budget challenge- Final numbers \$18,020 contributed by congregation towards. Need to do more communication to congregation toward budget time to let everyone know how we are doing financially. R. Wissinger received feedback from demolition of parsonage. Some positive, some negative. R. Wissinger said it was a wakeup call for some people of the long term financial stability of Zion. K. Huston expects an estimate of \$200,000-250,000 range for complete repair of stained glass windows.
- **ELCA Foundation follow up-** \$904 million fund. They find investments that mirror ELCA beliefs, invest in the thinking of the national church. Investments turned into shares. This endowment investment would help supplement our giving. K. Huston- Thoughts? Ad/fin is ultimately responsible for financial well being of the congregation. Initial \$25,000 investment, then bequest money can be assigned to endowment fund. We need to address technical issues, such as finding 3 long term members to act as signatories. We are hesitant to make officers signees due to turnover. There are 2 signatories required to make changes, so having 3 members would ensure changes could be made in a timely manner. A formal vote was held- Council voted in favor of moving forward w/ ELCA Foundation unanimously.

# MINUTES OF THE CONGREGATIONAL COUNCIL—cont

### May 10, 2021

Endowment fund policy guide- Bev will type up something.

**Staff Support-** R. Wissinger- No immediate concerns. Meeting last month. All vacations have been discussed and addressed.

**Constitution Compliance-** B. Slade audit workshop- Three people have committed so far, but she hasn't called anyone yet. June 19<sup>th,</sup> 10am. A question was asked if there should be some kind of record kept. A written letter had been drawn up in the past. If there is an anomaly, how will it be addressed? We will dispose of old audits, anything older than 7 years will be incinerated.

**Evangelism/ Stewardship-** K. Balcerak- Nothing for Mothers Day, nothing for Fathers day. There is a volunteer who wants to become reader and assisting minister, who comes to Saturday night services currently. We will reach out and offer assistance. The Saturday night service attendance has been encouraging, and larger than pre-pandemic.

**Membership contact information mailing-** A meeting on Thursday coming up. 72 people haven't responded. We are going to follow up with another letter. We will call if there is no response from the second letter. What can we do to attract people in person? Maybe a blurb in the newsletter? Maybe a blurb in the Newspaper? Something to advertise the Christmas in July service on the 25th.

**ELCA Open Door Grant-** This is a membership drive initiative. Dawn Seagren will follow up and was given materials.

"God's Work our Hands"- September 21<sup>st</sup>- Also a membership drive initiative.

**Parish Education-** G. Sechrist- VBS- Aug 28<sup>th</sup>. Pavilion by the lake, all day event? Haven't discussed the possibility or returning to in-person Sunday School.

**Property-** Greenspace area on Parsonage site. Maybe pavers? The limit for development is that anything requiring a permit can't be done.

Capital Improvement Projects- Sunday School- June 14<sup>th</sup> painting is scheduled to begin. Flooring is to be determined. Industrial carpeting was suggested, but also going to look into getting vinyl planking.

Window Reconstruction and Painting- Contractor bid waiting on bid.

Rec & Fellowship- K. Gaylor. Meeting this week.

**Social Ministry-** K. Gaylor- Saturday drive thru food pantry. Beginning at 10am. There will be pre packed family bags that will be taken to the office on carts. We will be counting families, but not taking down names. The first week we will start with 100 bags. It is scheduled until noon or when the bags are all handed out.

**Trinity 3-2-1-** R. Wissinger- Available for any suggestions to take to the group.

**Worship and Music-** Pr. Tedd –May 26<sup>th</sup> meeting. Decide if we will make changes to the worship services and get it in newsletter. Committee will actively pursue changes as needed to service. The committee wants Councils' blessing to make changes. The committees thinking is to proceed with caution for singing. Synod is leaving it to each individual church to decide how to reopen. Take incremental steps gradually to reopen, singing with masks in June, and proceed as conditions allow. Pr. Tedd is willing to have something in person on Wednesdays if there is an interest.

Financial report-May financials- income was good, expenses are continuing to stay low.Financial issue- S&T Bank CD matured today. This CD money + Mission endowment fund money will be combined to make an initial investment with the ELCA Foundation Don Seagren made a motion to send it to council for approval.

#### **Ongoing Congregational Issues**

A. Constitution- no word back from the Synod.

#### **B.** Property projects-

i **green space project-** area is seeded & grass is growing. A suggestion was made by K. Huston to replace the roof on the garage and paint it; a discussion ensued and it was determined that the garage should remain, but several other repairs should be made to it. It was suggested that the small red shed be torn down.

ii Sunday school flooring- Affordable Interiors bid was accepted.

#### iii window painting bids

**Review Elias Bids-**

Discuss Funding/ financing options- A suggestion was made by K. Huston to possibly take out a loan over 30 years to pay for it; or have a funding drive. Some of the windows were originally donated in memoriam, so if we have a funding drive, an additional plaque could be added that the window was restored in memoriam. Due to the recent budget challenge, it may not be the most appropriate time to have a funding drive for the window project. Another option may be to take out a line of credit. Due to the large cost of the job; a decision should be made by the full congregation. The windows are not at the point where they are falling in, but time is a concern. The work will be done in stages. They are in disrepair, and some are not structurally sound. Some of the windows look bad, but aren't going to fall in. We have an idea of what it will cost, so that is a first step. The windows haven't been addressed in 50 years, so at some point soon there needs to be something done. The Mission Investment Fund (MIF) is a possibility to obtain funding.

# <u>June 9, 2021</u>

The hearing devices at the pews aren't working, the earphones aren't working. The light comes on, but no sound comes through. K. Huston and S. Higgins tried to diagnose the problem with the audio system upstairs but were unable to make a determination.

**c. Status of worship-** Steps needed to return to traditional worship- Were there any issues with when Pastor wasn't there? No, the services ran smoothly. There was a positive reaction to the services for the weekend of June5th. 10-12 people attended Saturday night, 18 were at Sunday service.

**d. Online status-** Are online services going to continue? D. Seagren is willing to purchase a webcam if there is an interest. We also need someone to operate the equipment as well.

**e.** Congregation contact information- we can send more notices out. A discussion was made about forming an IT committee.

New business- R. Wissinger- The next Trinity 321 meeting is on June 15<sup>th</sup>. A topic that will be discussed is opening a Trinity 321 checking account to simplify things.

#### Committee issues discussed:

#### **Completed Projects**

- 1. The boiler inspector has finally passed our boiler and it has received a certificate of operation
- 2. The Fire Department did not approve relocating the fire alarm in the pre-school. Due to Disabilities Act guidelines it must remain as is
- 3.Third floor Sunday School area wall repair and painting is underway and will be completed in time for fall classes
- 4.Bid received from Don Huey to re-roof, paint and repair walls of the garage was received. This bid also included removal of the red storage shed behind the garage. Bid price was \$5,325.00. The committee tabled action on the bid and asked that council weigh in on proceeding with the project.
- 5.The committee discussed several ideas for financing the buildings window restoration project. Further exploratory discussions need to be held before. The committee will provide several options for the congregation at the November annual meeting.

#### **On Going Projects:**

- 1.With the demolition of the Parish House, the committee approved having electricity installed to the garage. This will be done by Pardee at a cost of \$700.00 **Completion Date July 2021**
- 2.March 19, 2021 Heavy rain exposed a continuing leak problem at the sixth street entrance to the church. Several contractors have addressed this in the past but no permanent solution has been obtained. This continues to be an ongoing issue. The committee is looking for solutions through Masons and roofing contractors

3. Three outlets in third floor Sunday school area need to be updated. Completion date July 2021 4. Bathroom faucet on third floor needs to be repaired. Completion date July 2021

- 5.Affordable Interiors will be replacing the third floor Sunday School flooring following completion of the wall repair and painting.. **Completion date August 2021**
- 6.Pastor Tedd has asked for a screen door on the Pastor's outside office door to be installed. The committee has taken this under consideration

#### **TRINITY 3-2-1 COMMITTEE MINUTES**

#### June 15, 2021

Hello to all family members in Christ,

Your Trinity 3-2-1 advisory board met on Tuesday, June 15th to discuss issues including the availability and the need for supply pastors when Pastor Tedd is not available. Along those same lines, defining what the pastor's time off means to us. We spoke about whether our church families were ready to start the call process for a second pastor. Lastly, we worked on clarifying and simplifying the Trinity 3-2-1 financial structure. All of these items are part of our group's evolution.

After reviewing the synod web site for supply lay ministers and pastors, we realized that first, there are not many available and second, those that are, for the most part, are already booked in the long term. We will periodically check back to see if anyone's schedule has opened up. Until then the board suggests that we continue our services with our assisting ministers following the synod guidelines.

On the topic of the pastor's time off, we recommend that when the pastor schedules vacation or any time off that it be truly time off or that they be compensated accordingly. For example, writing sermons ahead. This was a point that was not defined adequately when Trinity 3-2-1 was initiated.

The Question was asked if we thought our congregations are ready to start the call process to find a second pastor. Our feeling is that our church families would benefit from taking a year or two off to "heal" and build after such a challenging year.

Lastly, much of our discussion centered around reworking the Trinity 3-2-1 financial structure to a more user friendly form. At this point it is important to recognize the good work of board member Father Bill Geiger and Our bookkeeper Anne Marie Schweitzer. From building line item examples, writing thought provoking opinions and to helping us understand the advantages and pitfalls of other alternatives. Thank you both and thank you to our other board members. Together we have developed a more straight forward financial system. The financial secretaries will be informed as to what they can expect moving forward.
