# Zion's Future is in Our Hands (Part Three)

Kathy was twelve when her mother suddenly died. I can't imagine how anxious and utterly helpless she felt. Luckily she had family for support. Being the youngest of five siblings, she had her two sisters, both in their thirties by then and wives and mothers in their own right, to provide love and support. Her two brothers were older too. With one was in college and the other in high school, her brothers provided support on the home front as Kathy navigated her new life with her father, who was now sixty-one. She needed to mature quickly, learn to cook and help run the house. In essence she lost what was left of her childhood. Kathy also received a great deal of support from her church family. Her future sister-in-law's family brought her into their home on Sundays after church for a meal and some fellowship. She also received some unexpected love and support from her sister's mother-in law. Normally a cold and distant person, she unexpectedly showed support by suppling Kathy with things she needed that her father would not have thought of to provide.

By the time I was on the scene ten years later, much of the pain and heartache surrounding her mother's death had softened and more pleasant memories were thought of and shared. Kathy's mom was remembered for her love of life and family, and for her baking. The weekend pinochle games with friends were a tradition on Forest Avenue and the sight of Kathy's mom on the front porch of their house waving a dish towel to celebrate the Pirates World Series victory has been a cherished family memory. There were always baked goods to be consumed and the neighborhood friends of Kathy's brothers couldn't wait until the pies were ready on Saturday afternoon. Kathy's mother and her best friend Lula got together to bake Christmas cookies the quantity of which filled many large containers to be shared by all.



I am sure that many of you have had to overcome some unexpected downturns in your family history. For most of us, these events bring unbearable sadness and pain, but with the love and comfort from family we emerge from those dark times stronger and more resilient. Family grounds us and serves as both support and encouragement to move forward. Our church families can also be of great comfort and aid during these periods of despair and we should never be afraid to lean on them when support is needed.

Just like our biological families, our church family experiences the same periods when our future looks uncertain and particularly bleak. Many of you who have deep generational roots at Zion can point to some time when our church family was challenged to survive some crisis or another. Thankfully, those with the deepest Zion roots have steadfastly kept us on course. They recognize the value that church membership means in guiding and supporting us through life. This guidance and support is deeply rooted in who we are as Christians. And who we are as members of this community of faith.

There are times when we forget that we are all baptized in water and sealed with the cross of Christ. We will never be lost or forgotten and we are encouraged to love and protect each other on our life's journey. That is not to say that our faith won't be challenged from time to time because it surely will. What we must remember is that God's grace is free to us. All we have to do is accept it.

Zion is entering a period of self-reflection as our administration and finance committee begins to explore a path for our future. This is scary territory because it is apparent we are no longer who we once were. This challenges the validity of our good memories and casts doubt on what our future has in store for us. But facing these things together will provide us with a brighter future and bind us together in ways that will make us stronger than we now can imagine. As we travel down this road together, we must remember that the risen Jesus appeared to his disciples while walking on the road to Emmaus. He walked and talked with them, broke bread and shared scripture. He stayed with the disciples until they recognized him as the risen Lord. We also share our journey with the risen Jesus. He may not be physically present but he is with us in scripture and when we share the Eucharist. Let us not forget that Jesus also continues to fulfill God's promise for us. Our road may not always be smooth but we can have hope when we truly live Jesus' commandment to love and care for one another as we do ourselves.

# **Ongoing Zion Project Update**

# **Windows**

The Property Committee is awaiting new bids for the window restoration/replacement project. It was decided to divide Zion's 118 windows into several segments and address each as an individual project. This would allow us to make progress on the windows that are in need of immediate restoration/replacement. The project has been subdivided into seven sections:

Windows along the parking lot side of the annex wing – those facing Greystone Windows on the south side of the annex wing – those primarily facing the parish house site and Preschool playground

Windows on the south side of the annex wing and the lower windows along the south side of the Nave

Windows on the lower north side of the Nave (along Church street)

Windows on the South side of the Nave

Windows on the North side of the Nave

The "Jesus" Window

Since this project will consume several years, parceling out the windows as detailed above will allow for a more financially manageable process.

# Roof

TMR is currently in the process of completing the previously contracted repairs on our roof. In addition, TMR performed a complete re-caulk/seal of the outside ridge of the "Jesus" window as we attempt to continue to search for solutions to stop the ongoing water leak issue on the east side of the Nave. During their inspection of both our Nave roof and our annex wing roof, it was determined that our annex wing roof is in solid shape. Our Nave roof, however has about two years of life left and in some locations is in serious need of replacement. We asked TMR to provide bids on replacing the roof on the Nave and those will be forthcoming soon.

# **On-Line Upgrade**

Dobil has ordered all the equipment necessary for our on-line service offering upgrade to proceed. Representatives have met with Zion to review the installation process. Work will begin as soon as the necessary equipment and material is received. We are confident that this upgraded equipment will greatly enhance the worship experience of those who tune in to Zion online.

## **February 14, 2022**

#### Call to Order

- Pr. Tedd- There is a Zoom meeting with three Pastors on Feb 17<sup>th</sup> at noon to discuss ideas to help congregations without pastors.
- K. Huston-Sent in a letter to the PA Dept. of State to make sure incorporated documents on file with them were correct. They could not find anything on file. K. McCullough stated that it was not necessary to register with Dept. of State if we have an EIN number.
- K. Huston- There are two estates where we are beneficiaries that are in the process of being settled. Working with John Barbor to work through the process which should take 2-3 months. There is a process where an Inheritance tax report is sent which goes to the State, then the beneficiary gets notification.
- Census from last year 527 baptized members that is on file with the Synod has on file we have 219 actually baptized.
  - Pastors' Report- First grief and loss support group meeting has been moved to March. Also had 5 people for game night. Try again when it's warmer weather. Pr. Tedd thanked people who covered for him who covered and who will cover while he is away.
  - V. Review of Financial Report (January 2022). Motion to send for audit. Income \$12,800 O2 special focus account transferred to 2022 income. Transfer to cash reserve. Nothing out of the ordinary for expenses. Elevator expense 2x per year, Plus the two chair lifts. There is a budget surplus so far. R. Wissinger made a motion to send for audit, 2<sup>nd</sup> K. Balcerak

Administration and Finance – Kevin Huston- Strategic planning. Continue discussions in Adfin committee. Look at long term financial health of congregation. Talk of the most efficient way to use the building, as it's large and the amount of members who utilize it isn't as large. Long term ministry 30 years down the road. We will have to ask difficult questions to look for long term answers for the long-term sustainability of the congregation. ELCA Foundation-Ryan Ebner will come to April's meeting to help set up program for legacy money.

#### Evangelism /Stewardship -

K. Balcerak. Planning things for Mother's/ Father's Day. K. Huston- Pledge donation cards have been received. Pr. Tedd- Should we start thinking about 2023 Pledge donation cards? Some people were caught off guard by it, but it is a good way to plan for the budget for the upcoming year. We need to be upfront with budgetary situation. R. Wissinger

**Parish Education** – Gail Sechrist- The kids are practicing singing. Hope to have kids sing in church in the near future.

Youth- Adult ministries- no report.

**Property** – Dave Keith- New timer installed on Jesus window for \$148. A window leak has been repaired for \$1400; this should also fix the leak in the alcove. Roof repairs have been delayed due to weather. Roof may need replaced in a few years. The contractor will be coming back this week to talk about an estimate. A full replacement of the slate roof may be too expensive; may go to more traditional roof. The existing slate would be able to be sold to recoup money towards roof repair. A 2<sup>nd</sup> estimate for the stained window repair/ replacement from company in New York was \$829,000 after an extensive examination. The building is aging and is large and needs to be talked about. The organ is a good thing for ministry outreach. Try to think of ways to generate sustainable income. G. Sechrist-The left outside light is not working on 6<sup>th</sup> Street.

**Building Use** - Nothing

**Recreation and Fellowship** – S. Horner. Nothing new; there was a funeral meal which served 84 people. They were happy.

**Social Ministry** – S. Dickson- None

**Trinity 3-2-1** - Rik Wissinger- Tomorrow night is the quarterly meetingldeas for Lenten, holy week services, and a 5pm Ash Wednesday service will be discussed.

**Worship and Music** – Pastor Tedd- Working on rotation for people to visit members who wish to commune. There was an extravagant initial estimate for online ministries, it was pared down, and add on options later as necessary. Q tips have been discussed to use to dispense ashes on Ash Wednesday. One and done. Real ashes, not toner from copier. Palms will be ordered for Palm Sunday.

- **II. Financial Report** We received a call on Monday call from John Barbor, and the Mardell Fish estate is in the process of being settled. It will initially be deposited into the savings account.
  - **A. February Financials** Move some of the cash in the bank (\$252,324.03) into another account to generate some income. Think about reallocating Special Focus Envelope (\$28,645.40) for projected budget deficit from 2021. Phone and internet are running slightly ahead of where we budgeted. Need to keep an eye on it. Motion to send for audit. M/ R. Wissinger- 2<sup>nd</sup>/K. Balcerak

#### III. 2022 Initiatives

- A. Managing 2022 pledges (Stewardship) 55 pledges from families for the year.
- B. Membership Outreach (Worship and Music)
  - i. Home communion Rest of people are trained and have the list to go out to commune homebound partitioners.
  - li. On-Line Church- Audio was not very good for the last week. Don Rosenberger will be contacted to move forward with upgrading our electronics. The updated quote was a little over \$5000. Will move forward with the upgrade. This Saturday is a Constitutional review at 8:30am. Bev took the initiative to learn how to program the door locks and programed them for services.

#### **C. Strategic Planning** (Administration and Finance)

i. Financial Plan for Zion's long-term health - Make a list of assets and liabilities. Financial, structural, spiritual. Discussion- K. Huston. Assets - The organ presents an opportunity if we expand its use beyond. We have had a relationship with the music department at IUP for a long period of time and has been fruitful as it brings musicians into the congregation. It would be good to coordinate with IUP to continue the relationship long term. The Organ, choir, and musical nature of the congregation is an asset; we have a historic music background.

#### **ADMINISTRATION AND FINANCE COMMITTEE MINUTES—cont**

Liability - Not having an organ maintenance fund, there is wear and tear on it; some things are more expensive to repair than others. There was a suggestion made previously of turning the Steinway Piano Repair fund into a musical instrument repair fund. We will explore possibility of insurance policy for the organ. Asset - Downstairs social hall is an asset. Possibility of renting the area more frequently. Easy access to the building as well as parking is a liability. Liability - Lack of showers for church to be used as an emergency site. Do we need a sprinkler system in the social hall if we rent it out to the public? An asset - History of congregation and building; there have been numerous generations who have passed through the church. Building itself is an asset. Size of the building is beyond the size that we need right now which is a liability. Intangible assets/liabilities - Lack of younger members & activities for younger people to participate in non-church activities (food pantry, Sunday school). Think of ways to attract people, no longer doing mini recitals, advent luncheons. Christine is talking about starting a mini-series of concerts which would be nice. New opportunities for congregation to participate. Who are we trying to attract? Look for times and dates to plan things so that younger people can participate and make it more accessible. Preschool - Asset or liability? Amount of kids, outreach to community. Should we have a preschool Sunday? And invite the kids and families to a service. Do we make it a benefit for people who are members of the church to enroll in the preschool? Is it a benefit for the spiritual life of the church? Really think about assets and liabilities.
